Contestants must not receive any compensation or payment from a third party for entering the competition. **WINNERS AND PRIZES** 8. Prizes are non-transferable, non-exchangeable and not redeemable for cash. 9. All prizes awarded to the contestant must remain the property of the contestant. 10.
